New Business

- Community Session
- Guest Speaker: Samm Swarts
 - **Voluntary testing:** no CDC, local, or state guidance that stipulates we must test. High vaccination rate (99% for students)
 - About 30% of college population chosen randomly each week (includes students, staff, and faculty)
 - Over 90% participation in first few weeks, declined slightly in recent weeks
 - Employee vaccination rate:
 - 84.3% current vaccination, includes both staff and faculty/other college employees
 - Some employees still working in remote environment. Don't need to be vaccinated or testing. No exact number for this sector
 - Low COVID rates throughout this semester
 - Community reporting form
 - Anyone in campus community can report

- Identification information is optional (so form is anonymous)
- Form can be utilized for any event on campus
- Easy to find (can just Google Ithaca College community reporting form)
- Question: Lila: can you speak to President Biden's plan and new OSHA guidance regarding COVID protocols, especially in regards to mandated employee vaccination?
 - Answer: OSHA guidance new as of last week: similar to Biden's vaccination plan. Pretty lengthy plan that college is still sorting through. Before Biden's plan in effect, we were in compliance because high vaccination rate and anyone not vaccinated= required testing
 - So, we're currently in compliance with OSHA guidance and President Biden's plan
- Question: Leticia: Community reporting form in the case of students reporting faculty and staff members. Repercussions vary for student violations, what do repercussions look like for faculty and staff
 - Answer: we work through faculty's dean's office first, need to rectify any issue but if it's a bigger issue, potentially involves disciplinary action for faculty. For staff, start with supervisor to address issues, again potentially disciplinary action
- Question: Lila: With boosters becoming more available, does the college have any intention of requiring booster vaccinations for the campus community?
 - Answer: not all students are eligible for boosters. Until then, college won't seriously discuss requiring boosters. If/when that's a possibility, will communicate with campus community.
 - Cornell and TCCC also not requiring boosters at this time
- Question: Austin: Does the college have any plans to change current COVID protocols in the near future?
 - Answer: Lifted masking requirements in various schools in the past week. Transmission has not been occurring in classroom settings, it's been mostly in small gatherings where people are in close contact with no masks for an extended period of time
 - Hopeful that Spring semester will bring even more relaxed protocols
- Question: Leticia: For the community reporting form, if a student wants to report anonymously, are they still able to get a follow up report sent to them?
 - Answer: if anonymous, no way to get a follow up. Platform does not collect any data points.
- Question: Austin: with the testing we've been doing, how are we doing with positivity rates among different groups on campus
 - Answer: Dashboard updated daily by Samm Swarts. Currently 2 student cases and 2 employee cases.
